Membership increased slightly with nine new members joining us. Our financial position is strong and will be able to transfer \$500 into the Board Reserve for future capital needs. CALL TO ORDER: 17:30

Board Meeting Minutes: All members present voted to accept the September board minutes as written.

Treasurer's Report: Ed presented the board with the October financials and reported that the club's membership was up to 55 seniors and 2 junior members.

GENERAL BUSINESS

President's Report: Spike reported that members might see the Solar Project trucks using Green Road. Spike recognized Tony Blanchard and Peter Pappas for their part in hosting a very successful Fall Float-Fly, which allow the club to donate \$250 to the Kiwanis Club after expenses. This is the sort of credential that helps the club earn its AMA Gold Leader Club designation. Spike mentioned that Mike Fasulo was working out the details with regards to the club's annual Family Banquet, scheduled for December 6th at the Portland Golf Club's restaurant.

Budget & Dues: Ed went over the annual budget. He explained that the only extraordinary expense was for the porta-potty (\$350) which included a hand sanitizer unit and a lock. In short, the club had net gains of approximately \$260 for 2023. At this rate, the club would be incapable of rebuilding the Board Reserve in time for the next mower replacement (6 plus years) without a dues increase. After some discussion the board voted unanimously to increase the member dues to \$75.

For the Good of the Club: Elliott discovered that the AMA distributes grants to clubs that purchase an automatic external defibrillator (AED) within two months prior to submitting the grant application. There is a limited amount of grant money available annually, so the timing of the purchase is important. Many of the board said they'd happily donate to the cause and suggested asking for donations from the membership.

The skies over beautiful Watchic Lake in Standish were buzzing with all sorts of model aircraft on September 23 and 24 as the Propsnappers annual Fall Float-Fly was held with great success.

The two-day event was originally scheduled for the previous weekend, but unfavorable weather conditions were forecast so the organizers shifted the dates with cooperation of the Kiwanis Club. The new schedule worked out just great with Mother Nature providing a cool but beautiful Saturday and almost equally nice Sunday, although the winds on Sunday were a bit more challenging.

Planes of all sizes (both electric and glow-powered) were flown from the small beach-front location. Most models had floats, but a couple were amphibious...using their fuselage for flotation.

Tony Blanchard and Peter Pappas worked together to organize the weekend with Tony supplying transportation of Peter's rescue boat, which has been on-site for every float-fly in recent years. A few members needed to utilize the boat to retrieve their models which had become stranded for one reason or another. All planes were gathered up with no ill-effects, and everyone returned to shore more-or-less as dry as when they left.

This year we had several non-flyers make the trip to check out what flying off water is all about. We even had some family members in attendance including a couple of youngsters who thoroughly enjoyed seeing the models.

The Propsnappers schedules two float-fly events each season, one in the spring (usually in early May) and another one in September. If you're at all interested in seeing what it's like to fly off water, be sure to watch for the announcement of next year's events.

JUST A REMINDER

Entrance Gate Procedure

MONDAY THRU FRIDAY - We are permitted to keep the gate swung open while we are flying from 8:00AM to 4:00PM. Last one out closes and locks the gate.

ON WEEKENDS - The gate must be swung closed but left unlocked by putting the chain over the gate.

In either situation make sure the padlock itself is locked on the chain so it does not disappear. Thanks!

Hibernation for Our Porta-Potty

All members should be aware that our porta-potty will be fully pumped out and put to sleep for the winter on November 1st. It will remain closed until the warmer weather in May of next year. It will be secured with a keyed lock for the winter to avoid anyone using it when not in service... switching back to the combination lock next season.
